Instructions

Please read the following guidelines before completing this form. Please be aware that the bursary will not be applied until the beneficiary has been booked on to the Venture and their deposit payment has been received.

The aims of the fund

The Ventures Bursary Fund exists to ensure that no child or young person is prevented from going on a Venture because they cannot afford the full fees. However, the fund is limited, and we therefore set certain criteria in order to ensure that we are awarding bursaries to those who are most in need:

- 1. In applying for a bursary, you are confirming that the award of that bursary will enable a young person to go on a Venture who would otherwise be unable to go.
- 2. Historically, the Bursary Fund existed to support households where income is particularly low; usually this will mean that parents or guardians will be receiving welfare benefits such as income support. This year we are extending this offer of support to those families who are struggling due to the current cost of living squeeze and who are able to provide a rationale for the application.
- 3. We will also support families where three or more siblings are going on Ventures in the same year and where the family's finances cannot afford the fees for all of them.
- 4. Only one bursary per year can be awarded for each child or young person, except in exceptional circumstances agreed to by the Ventures and Falcons Office.
- 5. The Bursary Fund is one of a number of options for funding; others include young people's home churches and Trust Funds. We expect any grant from the Ventures Bursary Fund to be matched by awards from other sources.

How much can you request?

You can request a grant from the Bursary Fund for an amount **up to one third of the Venture price**, rounded down to the nearest pound. For overseas Ventures, we normally give a maximum bursary equivalent to the largest bursary which could be made to a UK-based Venture.

Which applications will be successful?

When you make an application, we ask you to confirm that the beneficiary meets the criteria above. Applications are not normally refused, but we do not have unlimited funds, and we may not be able to meet applications which reach us close to the time of the Venture.
